- 4. comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.

 - The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to
- 13. teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
 - Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and
- 14. Class XII examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.

- 20. The school is required to remit pending fee, if any
 - The extension of affiliation is being granted as one time measure. However, the cases where the Show
- 21. Cause Notice was communicated or grievance / legal cases are pending against the school, the Board will take appropriate decision in this matter
- The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and Hygiene
- 22. certificate, Fire Safety Certificate and Building Safety Certificate from concerned Govt authorities time to time
 - The school shall also maintain record of certificate, compliances, data and other records/information and shall be fully responsible to produce all such records before Board and appropriate Government
